This form is to be used to apply for an ADSL (internet) connection.

Conditions

A minimum contract period of 1 month applies for ADSL Services. A minimum fee applies for ADSL service installation and labour. Data services allow only SMTP, HTTP and FTP data to be carried. Allowances and data charges (MB and GB) are calculated on combined upload and download data transfer except for some traffic provided from time to time by Norfolk Telecom at no cost. Norfolk Telecom offers a roll-over service for unused data, this is for a period of one month only, after this time unused usage is forfeited.
